### **PLUTA attorney Florian Martin Schiller to keep Vitaminmarkt Staufenhof OHG operational**

Vitaminmarkt Staufenhof OHG, based in Hilzingen in the federal state of Baden-Württemberg, has filed for insolvency. Following this, on 13 February 2024, the Local Court of Constance ordered provisional insolvency proceedings and appointed Mr Florian Martin Schiller from PLUTA Rechtsanwalts GmbH as provisional administrator.

Vitaminmarkt Staufenhof OHG operates a regional market hall in Hilzingen, in the district of Constance, with a sales area of around 800 square metres. It offers high-quality regional, international and agricultural products and specialities as well as organic food and also operates its own gastronomy business.

Attorney Mr Florian Martin Schiller has informed all some 30 members of staff about the current situation. Their salaries are guaranteed for a period of three months thanks to specific substitute benefits provided under German insolvency law. Provisional administrator Mr Schiller from PLUTA said, "The business continues to operate and customers can shop as usual in the market hall. The café and bistro also remain open." Mr Schiller will be supported in the proceedings by business lawyer Mr Franco Caputo.

Managing director Mr Andreas Hägele said, "It has not been easy for me to take the step of undergoing restructuring under insolvency proceedings. In the past few days, however, I have held many discussions with business partners, employees and customers and realise there is overwhelming support from all sides. This gives us a great deal of motivation."

The reason for filing for insolvency is liquidity problems. High costs and consumer restraint due to elevated inflation levels are heavily impacting the company. The new building at the current location required a great deal of investment and was completed during the COVID-19 period but was not eligible for any subsidies at the time. In view of financial developments, the company has filed for insolvency to restructure its business as part of the proceedings.

### Promising concept

Vitaminmarkt Staufenhof OHG has its origins in a farm shop that has been run by the Hägele family for decades. Starting from the Staufenhof farm, the business has developed into a market hall over the years. The company is known above all for its potatoes, fruit spreads and farmhouse breads from its own production. The product range also includes seasonal fruit and vegetables from well-known producers in the region, cheese and dairy products, cereals and pasta, baked goods, spices, oils, delicacies, pastes, wine and spirits. In addition, the market hall has a fresh fish counter and a branch shop of a local butcher.
