As a result of the aggressive price war in the consumer electronics and entertainment electronics sector, the 2012-founded company had to be restructured and realigned. In the past few months, the PLUTA restructuring experts together with the company's management team have performed comprehensive analyses and implemented corresponding restructuring measures. "We made important decisions. The restructuring measures we have implemented have allowed us to prepare the company for the future. The court opened debtor-in-possession proceedings in November 2017. During debtor-in-possession proceedings, the management board remains in office. The company is allowed to manage the restructuring process itself, supervised by an insolvency monitor and generally supported by restructuring experts with relevant experience in this field. The Local Court of Landshut appointed Mr Oliver Scharl from the law and insolvency administration firm Müller-Heydenreich Bierbach & Colleagues based in Hallbergmoos as the insolvency monitor.
