### Weissglut restaurant in Amberg remains open for business

Weissglut GmbH, which runs the restaurant of the same name in Amberg, Bavaria, has filed for insolvency. Following this, on 5 June 2024, the Local Court of Amberg ordered provisional insolvency proceedings and appointed Mr Daniel Barth from PLUTA Rechtsanwalts GmbH as provisional administrator.

The PLUTA restructuring expert said, "The business is continuing to operate as normal. The restaurant staff are there to take care of diners. The team is motivated and the cooperation with the managing director is going very well." Attorney Mr Daniel Barth is being supported in the proceedings by business lawyer Mr Maximilian Wanko. The PLUTA team has already initiated the process of securing pre-financing of the substitute benefits provided under German insolvency law. The salaries of the 33 staff are therefore guaranteed for the months of May, June and July.

The team has also initiated an M&A process with the aim of putting the business on a viable footing with an investor. Mr Daniel Barth said, "The restaurant will have prospects if we find an investor. Over the coming weeks, we will therefore hold discussions with parties interested in coming on board."

The business filed for insolvency due to liquidity problems. While its revenues declined considerably in recent months, costs have stayed at a high level. The macroeconomic environment and noticeably high inflation have led many consumers to cut back on spending, leading to a decrease in restaurant visits.
